1. **Additional Labour (loading/unloading):** Charges are per man hour, minimum of 4 hours each.
 - Weekdays: \$78.81 per man hour
 - Saturdays: \$106.38 per man hour
 - Sundays & Holidays: \$106.38 per man hour
2. **Appointment/Notification:** Applies when a specific date/time of delivery or notification prior to delivery is requested. Applies on shipments weighing 0-39,999 lbs only. Shipments weighing 40,000 lbs or more are excluded.
 - \$47.22
3. **After Hours Pickup or Delivery:** Between 6 PM and 6 AM. Applicable to the terminal locations, points outside these terminal locations will be subject to additional charges.
 - \$197.03 minimum within metro areas
 - \$393.97 minimum beyond metro areas
4. **Bill of Lading Changes — Payment Terms, C.O.D., Cancellation, Shipping Weight:**
 - \$9.05 per change
 - \$35.08 minimum
5. **Border Clearance/Security Fees (U.S.-Canada):** Charges calculated on the billed weight of the shipment. Charges are billed in U.S. dollars.
 - \$1.11 per cwt
 - \$29.96 minimum / \$100.16 maximum
6. **C.O.D. (Collect on Delivery):**
 - 6% of C.O.D. amount
 - \$78.81 minimum
7. **Dangerous Goods:** Charges are calculated on the actual weight of the dangerous goods shipment.
 - LTL shipments (0-9,999 lbs) — \$55.12 per shipment
 - TL shipments (10,000 lbs or more) — \$79.57 per shipment
8. **Documents (Proof of Delivery, Bill of Lading copies):** This charge will apply when a copy of the document is requested and an electronic copy of the document is available through request on our web site (midlandtransport.com)
 - \$23.65 per copy
9. **En Route Stop-offs & Offline Mileage:** Offline mileage determined by taking total miles travelled minus the direct miles from origin to final destination.
 - \$137.88 each + offline mileage of \$3.89 per mile
10. **Heated Service:** Available October 15th to April 15th. Charges are calculated on the billed weight of the shipment.
 - LTL shipments (0-9,999 lbs) — 18% of freight charges, \$47.22 minimum
 - TL shipments (10,000 lbs or more) — 18% of freight charges, \$94.56 minimum
11. **In Bond Shipments:** Charges calculated on the billed weight of the shipment, and are in addition to border security fee.
 - \$10.72 per cwt
 - \$129.71 minimum / \$405.76 maximum
12. **Limited Access Locations - P/U or Delivery, including but not limited to:** Mines, Construction sites, Government installations, nuclear plants, Schools, etc: Will be calculated on the billed weight.
 - \$4.33 per cwt
 - \$78.81 minimum / \$157.59 maximum
- 12A. **Residential area or zone, inside and/or hydraulic liftgate pickup or delivery:** Will be calculated on the billed weight.
 - \$4.33 per cwt
 - \$78.81 minimum / \$157.59 maximum
13. **Lumpers, Sortation, Cross Dock fees:** Charges calculated on the billed weight of the shipment
 - \$1.82 per cwt
 - \$55.12 minimum / \$220.61 maximum

14. **Redelivery, Reconsignment, Relinquishment, Diversion:** Charges are calculated on the billed weight of the shipment.

- Name Only - \$34.93
- Within the designated terminal's service area - \$4.75 per cwt | \$78.81 minimum / \$315.17 maximum
- Outside the designated terminal's service area - \$34.93 minimum + applicable linehaul charge from original destination to new destination.

15. **Reports:** No charge for standard reports available on our website midlandtransport.com.

- \$81.18 per report

16. **Storage:** Charges calculated on the billed weight of the shipment.

- DRY — \$1.98 per cwt per day | \$47.22 minimum per day | \$110.33 maximum per day
- HEAT — \$3.15 per cwt per day | \$78.81 minimum per day | \$255.29 maximum per day
- REEFER — \$3.15 per cwt per day | \$78.81 minimum per day | \$299.39 maximum per day

17. **Tradeshows:** Midland Customers only; to Atlantic Canada only.

- \$4.33 per cwt
- \$78.81 minimum
- \$157.59 maximum

18. **Trailer Detention:** Apply when the trailer is detained by consignor/consignee beyond agreed loading/unloading schedule.

- DRY — \$149.71 per day
- HEAT — \$255.29 per day
- REEFER — \$299.39 per day

19. **Valuation Fee:** When the Bill of Lading indicates the consignor requires Midland Transport to accept liabilities up to a stated declared value, an excess valuation charge of 6% (six percent) of the total declared value in excess of \$2.00 per pound on the actual weight of the shipment will be assessed, subject to a minimum charge of \$10.00 per shipment.

20. **Waiting Time:** Apply when the vehicle is detained by consignor/consignee beyond agreed loading/unloading schedule.

- \$118.15 per hour

FREE TIME (allowance prior to charges applying)

- 0-1,999 lbs: 15 minutes
- 10,000-19,999 lbs: 1 hour
- 2,000-9,999 lbs: 30 minutes

21. **Weekend and Holiday Specials:** To be coordinated through Customer Service (1-888-643-5263). Applicable to the terminal locations. Points outside these terminal locations will be subject to additional charges. Rate shown is per hour, min. 4 hours.

22. **Special Delivery Charges:**

23. **Geographical Surcharge or Remote Areas:** Due to uncontrollable costs to Midland and to maintain our high level of service a cost recovery surcharge will be applied to all shipments destined to Newfoundland & Labrador. Charge will be assessed at 8.9% and \$435 on truckload moves. Remote areas may also be subject to additional charges.

24. **NL Fuel Tax Recovery Surcharge:** Shipments moving to and/or intra-Newfoundland and Labrador will be subject to the following Surcharge:

- Inbound to NL: 1% of freight
- Intra-NL: 1.5% of freight
- Max per load: \$40.00

25. **Non-Productive Pickup (LTL):** Applies when a customer requested pickup is not available when Midland arrives:

- \$63.24 per shipment (LTL)

1. **Additional Labour (loading/unloading):** Charges are per man hour, minimum of 4 hours each.
 - Weekdays: \$68.17 per man hour
 - Saturdays: \$84.47 per man hour
 - Sundays & Holidays: \$100.70 per man hour

2. **9 AM Delivery:** This charge will apply when 9 AM delivery has been requested. 9 AM delivery is only accepted to points outlined in the 9 AM service guide available at midlandtransport.com.
 - \$33.68

3. **Appointment Deliveries:** This charge will apply when an appointment delivery has been requested. Waiting time in excess of 10 minutes will be charged in accordance to the Waiting Time Surcharge.
 - \$40.57 per shipment

4. **Cheque Return:** This charge will apply for non-certified cheque pick-up service in which cheques picked up are made payable directly to the shipper. Exception: Cheque Return service is not available to MB, SK, AB and BC points.
 - \$27.17 per shipment
 - Refer to C.O.D. (Collect on Delivery) for certified cheque pick-up service.

5. **C.O.D. (Collect on Delivery):** The C.O.D. fee will be charged to the party paying the shipping charges. C.O.D. shipments are only accepted to direct service points. Exception - No C.O.D. shipments accepted to MB, SK, AB and BC points, or any points designated as offline or remote.
 - 2.50% of the C.O.D. amount
 - \$33.68 minimum
 - Refer to Cheque Return for rates for non-certified cheque pick-up service where cheques picked up are made payable directly to the shipper.

6. **Cash Collect Shipment:** This charge applies when delivery driver has to collect payment. Exception: Collect shipment service (cash or otherwise) is not available to MB, SK, AB, and BC points.
 - \$10.54 per shipment

7. **Controlled Shipment/"Chain of Signature":** This service is only available to direct service points as indicated by a D in the MC Zone Listing. Exception - Controlled shipment / "chain of signature" service is not available to MB, SK, AB and BC points.
 - \$25.20 per shipment

8. **Dangerous Goods:** Applies to shipments of goods regulated under the Terms & Conditions of the Transportation of Dangerous Goods Act other than consumer goods. Hazardous waste materials are not accepted. Dangerous Goods shipments are only accepted via Ground service to direct service points as indicated by a D in the MC Zone Listing.
 - \$52.74 per shipment

9. **Ground Shipments Upgraded to AIR Service:** Will apply for requests to retrieve ground shipments while in transit and upgrade to air service. Exception: Ground shipments upgraded to air service is not available to MB, SK, AB and BC points.
 - \$40.57 per shipment

10. **Heated Service:** Heated service shipments are only accepted to direct service points as indicated by a D in the MC Zone listing.
 - 15% of freight charges
 - \$21.14 minimum

11. **Heavy Weight Shipment Surcharge:** This surcharge is applied to heavy weight shipments based on destination of the shipment.

12. **Hydraulic Lift:** Available only to points listed on the 9:00 am Service Points List found on the Midland Courier website (midlandtransport.com) for \$68.29 per shipment. Shipments to all other points will be subject to an hourly rate of \$76.04 per hour, minimum 3 hours.

13. **Non-Conveyable Freight:** This charge will apply when any one piece in a shipment cannot be safely placed on a mechanical conveyor belt. This includes non-packaged goods - items that are not fully encased in a shipping container such as tires or pails; discretionary fragile items - due to their size, shape or contents such as glass, ceramics, or liquids; over-length pieces items that exceed 5 feet in length and/or overall size of 165 inches length and girth.

- \$19.53 per shipment

14. **Non-Productive Pickup:** Applies when a customer requested pickup is not available when Midland Courier arrives.

- \$10.21 per shipment

15. **Private Residence Pickup or Delivery/Residential Area or Address:**

- \$5.05 per shipment
- Signature capture required on delivery - additional charge per shipment: \$3.93

16. **Re-delivery/Reconsignment Charge:** This charge will apply when second and subsequent delivery attempts are incurred. This includes ALL redirects, reroutes and re-deliveries.

- \$21.14 per shipment

17. **Storage:** This charge will apply per day or part thereof.

- \$16.22 per skid per day
- \$32.47 minimum

18. **Waiting Time:** This charge will apply after the first 10 minutes of free time have elapsed. The charge will be applied for every 30 minutes or part thereof.

- \$51.98 per 30 minutes

19. **Waybill Changes - Including but not limited to: Address Correction, Payment Terms, COD Terms, Declared Value, Shipping Weight:**

This charge will apply when any required information is missing or incorrect on BOL.

- \$13.79 per change

20. **Weekend/After Hours Delivery:** Where available, prior arrangements must be made with your local Midland Courier branch.

- \$103.99 per hour or part thereof
- \$416.02 minimum

21. **Valuation Charge:** Declared values in excess of \$100.00 are subject to a valuation charge of \$5.00 per \$100.00 or part thereof. If the declared value exceeds \$999.99, pre-authorization by your local Midland Courier office is required.
